III. Presidents Report

- e. Alumni Victorious campaign kicked off with email and dedicated web site
 - i. Goal to purchase two new coxed fours and a trailer over the next 3-5 years
 - ii. We have received funds for all oars and one seat of the first four
 - iii. New Pocock Hypercarbon Bow-coxed four was delivered to Cleveland on April 10, 2008
 - iv. All alumni are asked to donate to the campaign and encourage their classmates to do so too

IV. Treasurer's Report

- a. SARA assets are just shy of \$20,000, which includes the positive alpha, oars but does not yet in include the new four
- b. Total cash \$9,389, not including expenditures for the new four
 - i. Balance up \$3,797 from last year
 - ii. Donations this year (since Jan. 2008) were \$2,500
 - iii. \$778 from cafepress, Amazon
 - iv. Outflows ~\$600 for insurance, boat maintenance

- v. 2008 expected rack rents
 - 1. positive alpha, \$125
 - 2. new four, \$300
- c. Tim Marcovy added to the Treasurer's Report
 - i. Capital campaign is ambitious what the team really needs.
 - ii. Case Crew trains mostly in fours. This new four just replaces the Sweet J, doesn't increase fleet.
 - iii. Case is biggest college squad at boathouse this year, and is the only team down at the boathouse that doesn't have their own trailer.
